#### ΗΙΡΑΑ

Compliance Manager helps Covered Entities and Business Associates maintain ongoing HIPAA compliance. The platform provides IT departments with guidance for addressing common HIPAA issues, finds hidden ePHI on servers and computers, documents HIPAA policy and procedure validations, and generates all required documentation for adhering to HIPAA guidelines, including generating an "accurate and thorough" Risk Analysis – the lack of which results in the most common and penalized HIPAA violation.

#### **GDPR**

Compliance Manager is the first purpose-built, compliance process automation tool designed to ensure compliance with the EU General Data Protection Regulation (GDPR). The module produces all required compliancy documents, including a Risk Treatment Plan, Data Protection Impact Assessment and GDPR Evidence of Compliance.

The Cybersecurity Maturity Model Certification (CMMC) is being rolled out for the 300,000+ non-federal organizations that make up the Department of Defense supply chain. Compliance Manager guides DoD contractors through the certification-readiness process for Levels 1, 2 and 3, as well as the NIST 800-171 Interim Rule, and once certified by a 3PAO, helps document ongoing compliance to the standard.

#### **NIST CSF**

Compliance Manager uses the NIST Cybersecurity Framework (CSF) as the basis for many industry-specific security standards, including the NIST 800-171, New York SHIELD Act, and many others. Our automated data collection and user-driven walkthrough simplifies security compliance and documentation.

#### **CYBER INSURANCE**
